irrevocably declares accession to the **United Organizations (UO)**, operating under the International Human Rights Commission – IHRC with headquarters in 118 00 Prague, Loretanské náměstí, 118 00, Czech Republic (ID 05967023) represented by Secretary General IHRC on the terms and rights set out below.

Art 1.

The **Organization** joining the **United Organizations** undertakes to share and promote outside the values recognized by members of the **United Organizations** as well as to promote the image, logo and other markings of **United Organizations** and its members in their current operations.

Art 2.

1. The **Organization** undertakes to conduct a minimum of 4 times a year (preferably at least in each quarter) a local humanitarian operation for the benefit of persecuted, poor or excluded people.
2. The **Organization** undertakes to carry out a minimum of 2 times a year (preferably at least in each half-year) a supra-local humanitarian action with another **Organization** for the persecuted, poor or excluded.
3. The **Organization** is obliged from the moment of accession to use, as part of its day-to-day operations and on all printed and electronic materials, the IHRC logo and its other markings.



4. As part of the preparation and implementation of the actions referred to in points 1 and 2 above, the **Organization** is also required to publish the logos of other organizations participating in them.
5. Preparation of the press release and photo service from the above actions documenting its conduct and submission to HQ **United Organizations** for publication on IHRC websites.
6. Actions of the **Organization**, from which HQ IHRC will not receive the materials specified in item 4, shall not be considered fulfilled in accordance with items 1 and 2 of this article.

Art 3.

1. In case of failure to comply with the above requirements, such an **Organization** shall pay the account to IHRC by bank transfer of a fee of a minimum value of 10 (ten) Euro for each month of the year, in which it was a member of **United Organizations**.
2. The amount of the fee and the manner of its payment will be notified to the **Organization** in writing by IHRC in the first quarter of the following year.
3. Failure to settle obligations under the conditions set out in point 2 of this article, shall mean the removal of the **Organization** from the list of members of the **United Organizations**, publication of this fact on portals and withdrawal of the rights set out in Article 4 of this Accession.

Art 4.

United Organizations, upon the accession of the **Organization** and for the time of its membership, grants the **Organization** the right to use the logo, signs and full and short name of **United Organizations** for the promotional purposes of the **Organization** and its statutory activities in accordance with Article 1 of this Accession.

Art 5.

1. Can't be a member of **United Organizations** an **Organization**, that is unlawfully using logos, marks or other terms assigned to other Organizations, with particular emphasis on supranational organizations such as the UN, as well as similar marks and terms that may be misleading as to the membership of the **Organization** or its associations.
2. **United Organizations** members are prohibited from cooperating with the organizations referred to in item 1 of this article.



3. In case of a breach of the rules set out above, such **Organization** will be immediately removed from the list of members of the **United Organizations**, which will be published on the portals.

Art 6.

1. Any disputes within the **United Organizations** and between its members and external entities will be settled through mediation, and in the event of its ineffectiveness, will be absolutely resolved by the "**Federation of Human Rights Arbitration - Federal Court**" on the principles applicable in it.
2. This Accession does not limit the previously specified obligations of the Parties to Accession, unless they conflict with the idea and provisions of this Accession. In case of a conflict, the Accession provisions will abolish it.
3. This Accession shall enter into force on the day of its signature by a representative of **United Organizations** and is concluded for an indefinite period, taking into account the principles set out herein.
4. The accession was concluded in two identical copies, both with original rights, one for each of the Parties.
